The 2019 HRH of New Jersey Horse Show will run according to USEF and Special Olympics rules. The show will be held rain or shine.

Late entries will not be accepted.

### General Rules It is your responsibility to read the rules thoroughly!

- 1. The Show is open to riders of all ages and disabilities. Riders do not need to be part of a Local Training Program (LTP).
- 2. SO rules require athletes to be eight (8) years old or older to compete.
- 3. All riders must wear ASTM approved protective headgear when mounted.
- 4. Proper and substantial shoes with heel must be worn.
- 5. Appropriate riding attire is encouraged but not required.
- 6. No rider shall be attached to the horse or tack by straps, Velcro, or other means.
- 7. Ring #1 (Equitation) will take priority over Ring #2 (Obstacles) and classes will not be held up if a horse(s) are unavailable when called for a class.
- 8. Competitors with Down Syndrome may not compete if they have a positive diagnosis for atlantoaxial.
- 9. There is a maximum of eight (8) participants per class. The Show Management has the right to combine, divide, or cancel classes as entries warrant. Every effort will be made to announce changes at the start of the show.
- 10. A negative Coggins for each equine must be included with the show entry. Coggins must be taken within 24 months of the show date for NJ stabled horses, 12 months for out-of-state stabled horses. Out-of-state horses must also have a current health certificate present at the show.
- 11. Any equine stabled overnight must have a groom present at all times. Stall rent is available starting Friday evening. The cost is \$40.00 per stall. Bedding is not provided. Straw bedding is not permitted. The stall does not need to be stripped after the show.
- 12. Horse and/or tack cannot be in the stall area unless a stall has been paid for. Horse stall/tack stall is \$40.00 and must be reserved and paid for with the show entry.
- 13. Please see Isaac Trophy class description and Entry Form for the Isaac Trophy class rules.

#### General Rules Continued

- 14. Each Program/LTP must submit all entries, fees, Coggins, and releases together. No entries will be accepted from individual riders separate from the program entries.
- 15. A horse may not be shared with more than two riders entered in the same class.
- 16. If an equine is entered in two classes with time conflicts, a gate hold must be requested for one of the classes at least two classes prior to the conflict. To a gate hold, notify the gatekeeper of the appropriate ring, provide the rider's number, horse's name, and class number. This will give an additional five minutes before the start of the class.
- 17. In each class all riders are judged for HRH and only verified SO riders compete for SO ribbons and medals.
- 18. Riders cannot cross enter divisions. (e.g. walk/trot/canter and walk/trot)
- 19. All classes will be judged on horsemanship; the rider's equitation and effort to guide and control their mount.
- 20. Riders competing with western saddles will be judged at the jog instead of the trot and at the lope instead of the canter.
- 21. Hearing impaired riders must provide his/her own sign language interpreter if needed.
- 22. All riders warming up horses must wear a helmet and sign the HRH Release Form and submit it to the Show Office before riding.
- 23. Horses may be warmed up/lunged in designated areas only.
- 24. All dogs must be leashed at all times. Dogs disrupting the horse show will be required to leave.
- 25. Alcoholic beverages and bicycles are not permitted at the Horse Park.
- 26. The schedule may change if the show has to be moved to the indoor.
- 27. In order to keep to the time schedule the gate will close after five minutes. Please be ready to enter the ring at the appropriate time.
- 28. NO REFUNDS for any reason. Refunds will only be given if the class is cancelled by the Show Management and the entry cannot be moved to another class.
